- The population in this area is estimated to change from 30,776 to 32,739, resulting in a growth of 6.4% between 2000 and the current year. Over the next five years, the population is projected to grow by 7.6%.

The population in the United States is estimated to change from 281,421,906 to 292,936,668, resulting in a growth of 4.1% between 2000 and the current year. Over the next five years, the population is projected to grow by 4.8%.

- The current year median age for this population is 33.6, while the average age is 34.6. Five years from now, the median age is projected to be 34.6.

The current year median age for the United States is 36.0, while the average age is 36.9. Five years from now, the median age is projected to be 36.7.

- Of this area's current year estimated population:  
71.8% are White Alone, 20.9% are Black or African Am. Alone, 0.5% are Am. Indian and Alaska Nat. Alone, 2.4% are Asian Alone, 0.0% are Nat. Hawaiian and Other Pacific Isl. Alone, 1.3% are Some Other Race, and 3.1% are Two or More Races.

For the entire United States:

73.8% are White Alone, 12.4% are Black or African Am. Alone, 0.9% are Am. Indian and Alaska Nat. Alone, 4.0% are Asian Alone, 0.2% are Nat. Hawaiian and Other Pacific Isl. Alone, 6.1% are Some Other Race, and 2.7% are Two or More Races.

- This area's current estimated Hispanic or Latino population is 4.2%, while the United States current estimated Hispanic or Latino population is 14.0%.

- The number of households in this area is estimated to change from 11,082 to 11,889, resulting in an increase of 7.3% between 2000 and the current year. Over the next five years, the number of households is projected to increase by 8.6%.

The number of households in the United States is estimated to change from 105,480,101 to 109,949,228, resulting in an increase of 4.2% between 2000 and the current year. Over the next five years, the number is projected to increase by 5.0%.

- The average household income is estimated to be \$57,119 for the current year, while the average household income for the United States is estimated to be \$63,301 for the same time frame.

The average household income in this area is projected to increase 10.4% over the next five years, from \$57,119 to \$63,066. The United States is projected to have a 13.3% increase in average household income.

- The current year estimated per capita income for this area is \$20,945, compared to an estimate of \$24,092 for the United States as a whole.

- For this area, 43.7% of the population is estimated to be employed and age 16 and over for the current year. The employment status of this labor force is as follows:  
8.1% are in the Armed Forces, 57.8% are employed civilians, 4.2% are unemployed civilians, and 29.8% are not in the labor force.

For the United States, 46.6% of the population is estimated to be employed and age 16 and over for the current year. The employment status of this labor force is as follows:

0.5% are in the Armed Forces, 59.9% are employed civilians, 3.6% are unemployed civilians, and 35.9% are not in the labor force.

- For this area, 43.7% of the population is estimated to be employed and age 16 and over for the current year. The occupational classifications are as follows:

24.1% have occupation type blue collar, 58.1% are white collar, and 17.8% are Service & farm workers.

For the United States, 46.6% of the population is estimated to be employed and age 16 and over for the current year. The occupational classifications are as follows:

24.0% have occupation type blue collar, 60.0% are white collar, and 16.1% are Service & farm workers.

- For the civilian employed population age 16 and over in this area, it is estimated that they are employed in the following occupational categories:

12.5% are in "Management, Business, and Financial Operations", 19.1% are in "Professional and Related Occupations", 17.4% are in "Service", and 26.6% are in "Sales and Office".

0.3% are in "Farming, Fishing, and Forestry", 10.3% are in "Construction, Extraction, and Maintenance", and 13.8% are in "Production, Transportation, and Material Moving".

For the civilian employed population age 16 and over in the United States, it is estimated that they are employed in the following occupational categories:

13.6% are in "Management, Business, and Financial Operations", 20.2% are in "Professional and Related Occupations", 14.8% are in "Service", and 26.7% are in "Sales and Office".

0.7% are in "Farming, Fishing, and Forestry", 9.5% are in "Construction, Extraction, and Maintenance", and 14.5% are in "Production, Transportation, and Material Moving".



- Currently, it is estimated that 9.7% of the population age 25 and over in this area had earned a Master's, Professional, or Doctorate Degree and 14.6% had earned a Bachelor's Degree.

In comparison, for the United States, it is estimated that for the population over age 25, 8.9% had earned a Master's, Professional, or Doctorate Degree, while 15.7% had earned a Bachelor's Degree.
